Report-backs:

- <u>UCA Miami</u>: While on a project in Miami, spoke with colleagues at Miami Lex and FTI Consulting who were interested in organizing. Some Miami contract attorneys received the survey link and completed it. One contract attorney had a Miami Herald reporter interested in her story, but because she did not want her name in the article, the reporter could not publish the story. Another colleague suggested that the UCA speak to the reporter on her behalf. The local CWA could not facilitate a meeting in Miami due to their main location in Fort Lauderdale and lack of capacity. However, some contract attorneys expressed interest in following the work of the UCA and meeting further. Next steps: add them to the listsery.
- Health Insurance: We're in the process of obtaining information to determine of a group-rate
 for health insurance for contract attorneys would be possible and to see if such a group could
 carry that insurance from agency to agency. At this time, however, it seems as though ACA rates
 might already be lower than any group rate we could get. Further information is still being
 sought out.

After analyzing the results of the survey, we have decided to post job notices that are paying a minimum of \$32.00 per hour. We also do not post job notices that do not pay overtime after 40 hours. One of the main goals of our organization is to push for a fair wage for contract attorneys and at this time we feel this pay rate is a good place to start. Any further input you have to offer is welcomed.
